Lawton Community Schools is seeking preliminary bids for our Elementary West parking lot renovation. 780 East 2nd Street.

Job includes removal of all old asphalt, repaving / restriping. Existing drain on North end will need to remain and be functional per design. Bid specification and forms available on the District website. www.lawtoncs.org

PROPOSAL GUARANTEE:

The proposal must be accompanied by a certified check or bid bond by an approved surety company in the amount of five percent (5%) of the proposal submitted. Proposals shall remain firm for a period of forty-five (45) days after official opening of bids. CONTRACT SECURITY: The successful Contractor will be required to furnish performance, labor and material bonds, each in the full amount of the proposal.

All proposals shall be accompanied by a sworn and notarized statement disclosing any familial relationship (or lack of a relationship) that exists between the Owner or any employee of the bidder and any member of the Board of Education of the Lawton Community Schools or the Superintendent of the School District. The District shall not accept a bid that does not include a sworn and notarized disclosure statement.

Iran Affidavit:

The bid shall be accompanied by a sworn and notarized statement pertaining to the IRAN ECONOMIC SANCTIONS ACT compliance of Michigan Public Act NO.512 of 2012.

AWARD:

It is the intention of Lawton Community Schools to award the contract to a bidder fully capable, both financially and as regards to experience and to perform and complete the work in a satisfactory manner. Each bidder under consideration may be required to submit a certified statement of his experience and financial status. 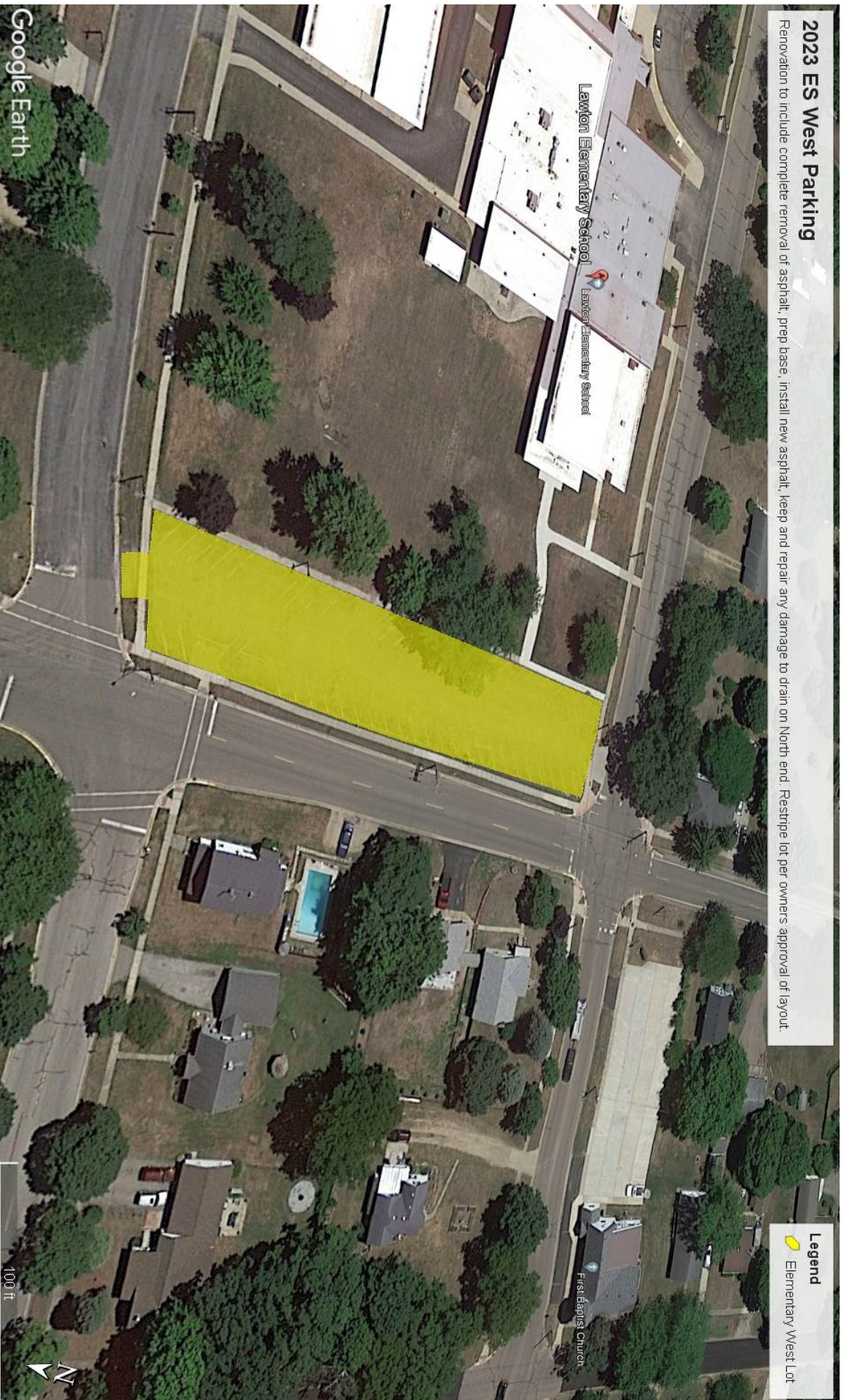
